TENDER NOTICE- OK SCHOOL Painting

The Nisichawayasi Nehetho Culture and Education Authority ("NNCEA") is seeking bids for the renovation of OK School Main Lobby and Administration Hallway (the "Project"). The Project includes supplying all required materials and painting the identified areas. This project will prepare our school to be further painted with murals (not apart of project). The Project contains, among other things, the following requirements:

- Patch any holes as needed and remove any materials on walls (posters, frames, whiteboards)
- Cover all conduit, outlets, and other non-removable materials
- Prime all identified areas x1
- Paint all identified areas x2
- Provide all materials for project
- Scissor lift on site supplied by NNCEA
- Ensure safety of workers, materials, and building
- Any other items that were identified in the original tender posting
- Provide evidence of compliance with workers' compensation legislation;
- Obtain, at its own cost, all necessary permits.

Contract stipulations, including responsibilities and liabilities of the parties, payment schedule and scope of work are available for review by all bidders at the Alice Moore Education Centre or via email by contacting nicc@nncea.ca

Bids will be accepted by Nic Campbell via email at nicc@nncea.ca or in person submitted to the Alice Moore Education Centre in an envelope prior to the submission date set out below.

Submission date: May 9, 2024 at 12:00 p.m. Bids cannot be withdrawn after 5 days of the submission date.

All or lowest bids not necessarily accepted, if there are no bids that meet the needs of NNCEA, the Project may be re-tendered or terminated. Selection criteria is based on price, experience, and compliance with NNCEA requirements set out above.

Contractor Responsibilities and Liabilities

- 1) The Contractor is responsible to perform the work in a good and workmanlike manner and to correct any defective work or work not performed as provided for by NNCEA, at its request.
- 2) The Contractor is responsible for obtaining and paying for any required permits, licenses or certificates necessary for the performance of the work (National Building Codes of Canada or Provincial Construction Regulations and Manitoba Hydro).
- 3) The Contractor shall provide evidence of compliance with workers' compensation legislation including payments due thereunder, if applicable.
- 4) The Contractor is liable for the actions of all of its employees or sub-contractors that are engaged to perform work in relation to the Project.
- 5) The Contractor is responsible for the safety of all persons it permits on the site during the duration of the Project.
- 6) The Contractor is responsible for obtaining and paying for all tools, materials, and equipment, including safety equipment, it requires in relation to the Project.
- 7) The Contractor is responsible to inform the NNCEA Director of Education of any unsafe health hazards or conditions that may arise throughout the course of the Project.
- 8) Any additional work that may be required by the Contractor will be negotiated between the Contractor and NNCEA. Any additional work should not commence until approved by NNCEA in writing.
- 9) The Contractor shall provide the required notices and comply with the laws, rules, regulations, and codes which are or become in force during the Project and which relate to the Contractor's work, to the preservation of the public health and construction safety.
- 10) The contractor is responsible for acquiring all required permits for all trades and building and to coordinate all trades, hook ups, and procedures of the build.

Responsibilities of NNCEA

- 1) Provide Contractor with access to the Project site during hours requested by the Contractor.
- 2) Communicate with the Contractor about any on-going needs and status updates.
- 3) NNCEA shall be responsible for the payment of unforeseen, reasonable expenses affiliated with the Project if the Contractor and NNCEA agree in writing to any additional costs.
- 4) NNCEA will not to be liable for any damages sustained by the Contractor during work it undertakes in relation to the Project.
- 5) NNCEA will provide 1 scissor lift on site. Contractor responsible for damages caused by negligence

Schedule and Payment Schedule

- 1) NNCEA will negotiate with the Contractor a schedule for the completion of the Project, with an end date of July 23, 2024, unless a later date is agreed upon by the parties.
- 2) NNCEA will negotiate with the Contractor a fair payment schedule to reflect the work being done (this may include a 25%, 50%, 25% payment schedule).
- 3) All payments will be subject to legislation and statutory regulations respecting holdback percentages.

Scope of Work

- Contractor is responsible for providing all materials for this project
 - Contractor is responsible for removing any obstructions such as: 1 whiteboard, 1 cabinet, 1 tv, 1 large frame, and other miscellaneous signs.
 - Contractor is responsible for re-installing all obstructions removed from walls
 - Contractor is responsible for ensuring all conduit, outlets, and permanent obstructions are covered up (including windows and door swings)
 - Contractor is responsible for patching any holes in walls and preparing all walls
 - Contractor is responsible for priming 4,107 square feet of walls with 1 coat
 - Contractor is responsible for painting 4,107 square feet 2 coats (colour TBD, will be white semi gloss, grey, or dark grey)
 - Contractor is responsible for priming x1 and painting x1 ceiling approx. 1020 sqfeet
 - Contractor is responsible for the safe storage of material.
 - Contractor is responsible for ensuring site cleanliness and disposing of garbage and scraps
 - Contractor is responsible for providing any extra materials to NNCEA
 - Contractor is responsible for the safety of all employees and sub contractors
 - Contractor is responsible for the safety of the workspace with appropriate safety signs and coverage
 - Any other items that were identified in the original tender posting
 - Project cannot interfere with school hours from 8:00am to 4:00pm. School hours conclude June 27, 2024 in which there are no hour restrictions after June 27, 2024.

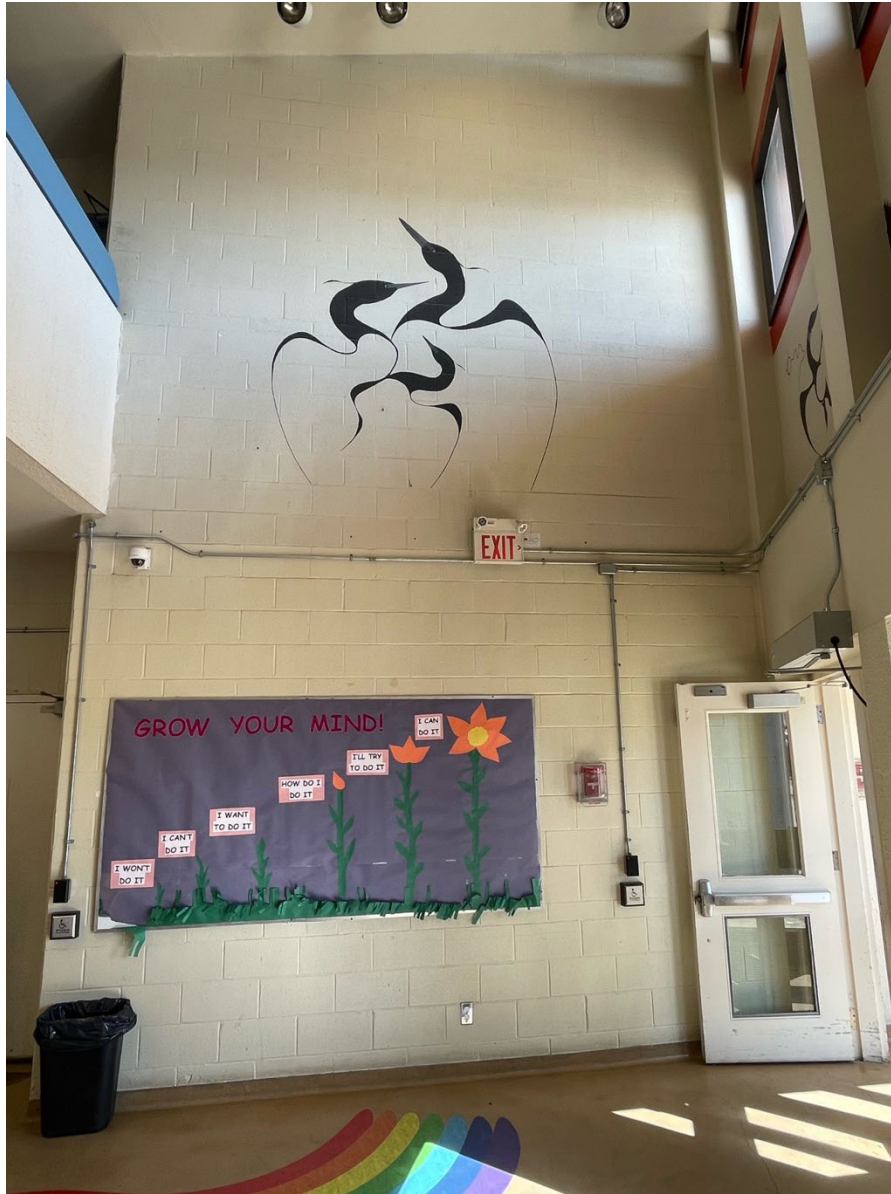

...of the school, or parent if the student is under age, is required to meet with the suspension review and administrative committee are reviewed under certain circumstances.

Restoration - The student, or parent if the student is under age, is required to meet with the suspension review and administrative committee. Such restoration may be necessary in future but does not constitute a return to school.

Administrative/Restoration Committee - In some instances, the student is required to meet with the suspension review and administrative committee. Such an agreement is required in order for the student to return to school, the parent and the student. Outcomes of the committee are developed before the student returns to school, such as an agreement to meet the behavioral standards.

Alternative Programming - Staff may be involved in planning alternative programming for students who are suspended. Such programming may be approved by administration and communicated to the student. Such a message will be approved by administration and communicated to the student.

Alternative Environment and Planning - The Principal or designee is called into action when a school is faced with a student(s) who is threatening violence to him/herself or others.

Child Abuse Investigation - In some circumstances, student infractions have implications that extend beyond the jurisdiction of the school. In such cases personnel from outside agencies (i.e., Child and Family Services, Mental Health, RCMP, etc.) are contacted as necessary or as required by law.

Suspension - In all cases of suspension, the parent will be notified.

In-School - The student is suspended from the classroom and placed in a supervised alternative setting.

A suspension from school is where the student is not allowed to attend school or school sponsored activities for a period of time. In all cases the suspension is subject to appeal with the minimum eight (8) days before one week unless approval from the Director of Education has been obtained to extend the suspension period.

Expulsion - Expulsion requires an official action by the Board of Education and is completed in accordance with NIEA Policies and Procedures. An expulsion means that the student is not allowed to attend school, join in any school sponsored event or activity or be present on school property until such time as the Board may remove the expulsion.

* Appeal - Parents may appeal disciplinary decisions taken by the schools by first contacting the school administration and then contacting the Director of Education for the Nelson House Education Authority.
